

TRACKING EXTREMISM IN ILLINOIS:

County Reports on Hate Incidents in Illinois (2020 - 2024)

Springfield, IL, April 9, 2025 - The Midwest Regional office of the Anti-Defamation League compiled a detailed breakdown of hate incidents across Illinois – providing county-level snapshots - from 2020 through 2024. They cover a wide range of incidents, from hate crimes to extremist activities to intimidation through hate leafletting aimed at immigrant, Black, Jewish, Muslim, LGBTQ+, and other vulnerable communities. The goal is to highlight the increase in these incidents and offer recommendations for how Illinoisans can address and prevent them moving forward.

Key Findings:

- **Statewide Trends:** Hate incidents have increased significantly in recent years, whether looking at ADL's data or the annual FBI Hate Crimes report.
- **County-Specific Data:** The reports break down incidents by county, highlighting regional differences in the frequency and nature of hate crimes. The findings include examples of extremist groups distributing propaganda and engaging in hate speech throughout the state. Not only does the granular data demonstrate the value of tracking and reporting hate crimes and incidents, the complete lack of reporting in dozens of counties across Illinois displays a glaring gap in data, limiting the full picture of extremism in Illinois.

- **Extremist Groups:** The reports spotlight extremist groups operating in Illinois, shedding light on their activities and the white nationalist and anti-government rhetoric they promote.

Key Recommendations:

- Create a statewide strategy to address the rise of hate and extremism.
- Strengthen legal protections against harassment by extremists through the Neighborhood Freedom from Intimidation Act.
- Ensure all law enforcement agencies receive proper training on hate crimes to improve response and prevention.
- Improve coordination among law enforcement agencies to better track and respond to extremist threats.

These reports aim to shed light on the current state of hate incidents and extremism in Illinois and offer practical solutions for how the state can better protect its residents from these rising threats.

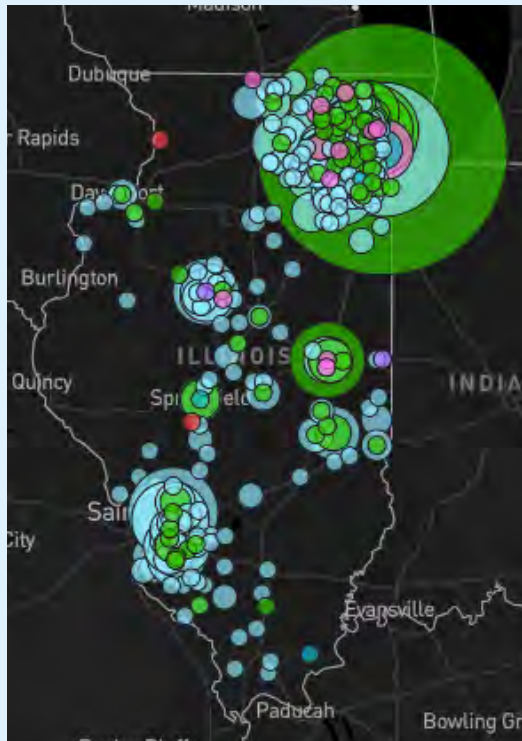

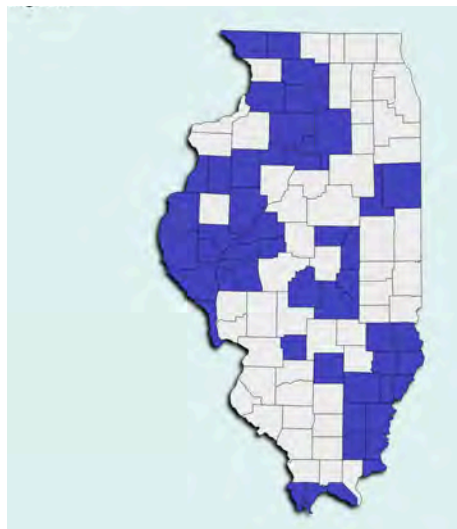

“Data about hate crimes, however, do not draw an accurate picture of the problem of hate in Illinois or in the country. Many victims do not report incidents. When victims do report, law enforcement officers may or may not record or investigate those incidents as hate crimes. Additionally, federal law does not require local and state law enforcement agencies to collect or report hate crimes, leading many municipalities, even those who have highly publicized hate incidents within them, to be on record with zero hate crimes.” - Illinois Commission on Discrimination and Hate Crimes

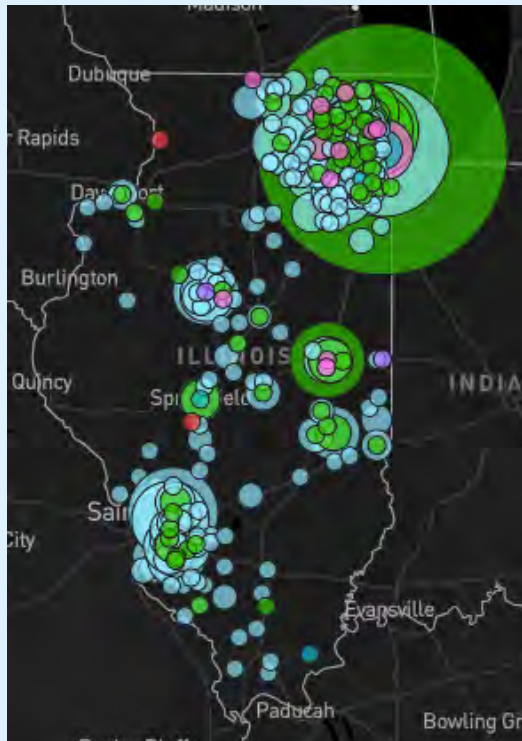

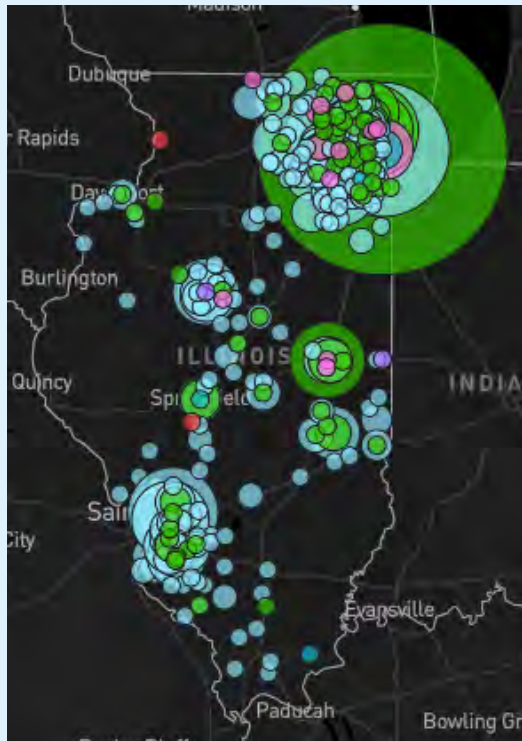

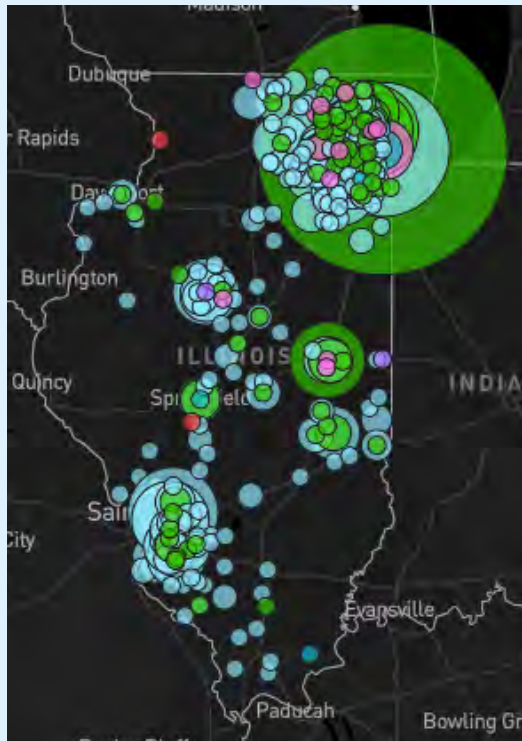

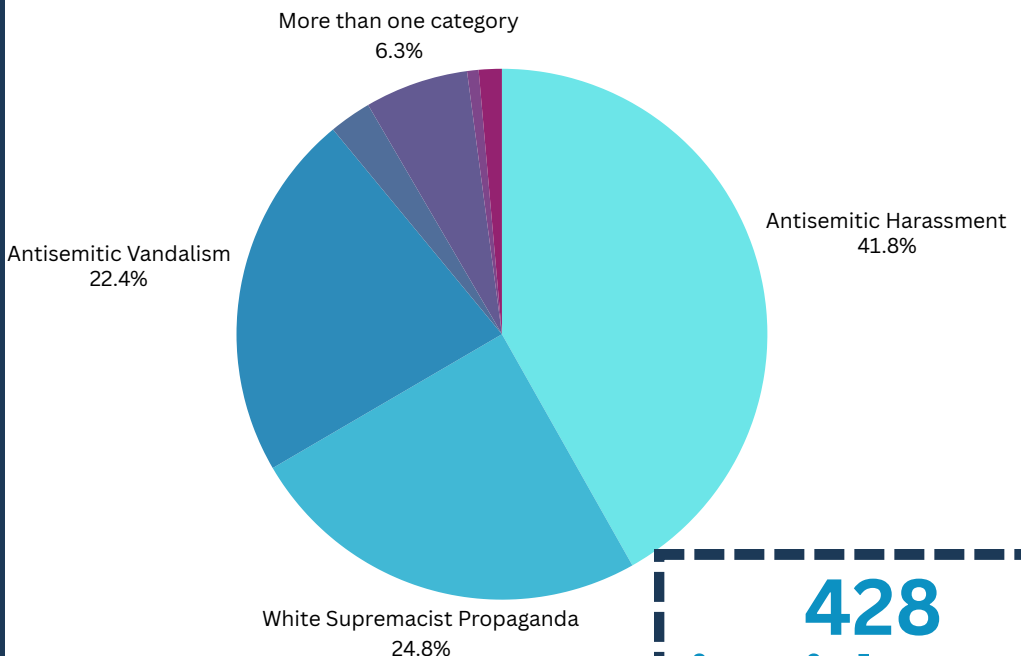

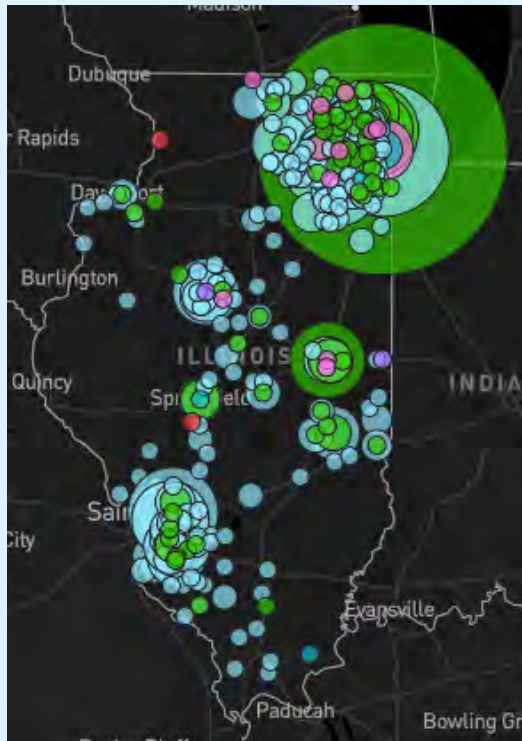

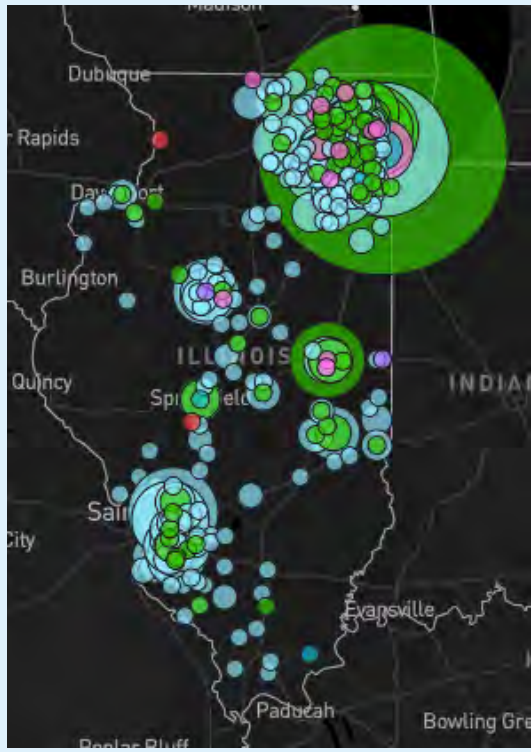

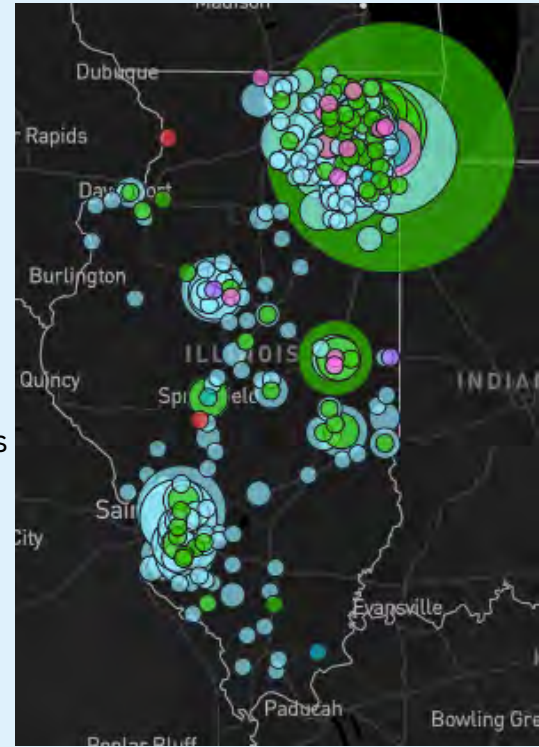

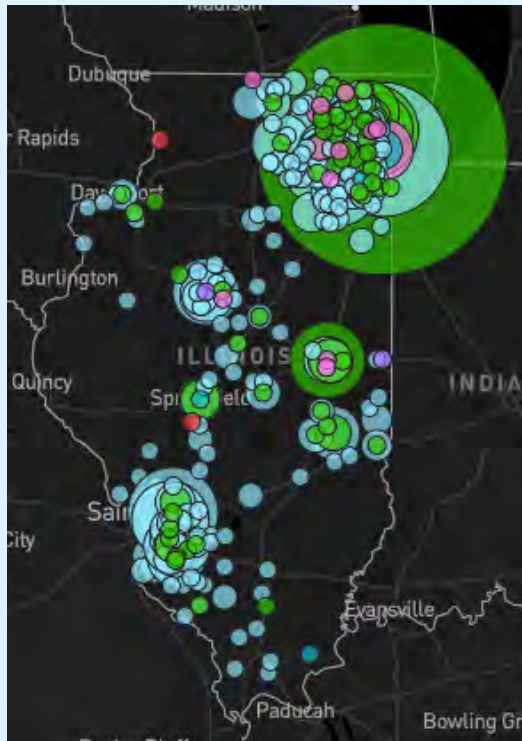

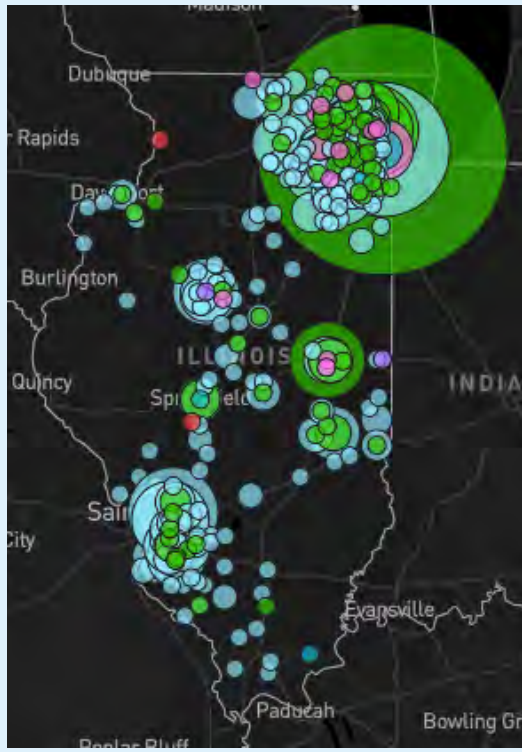

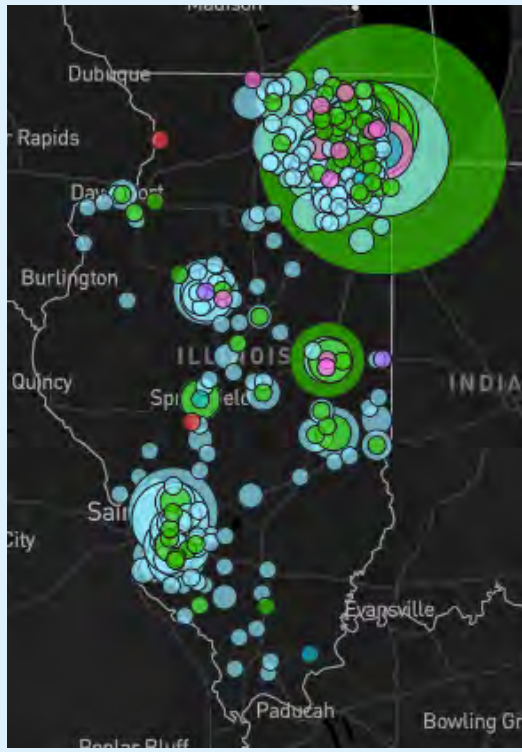

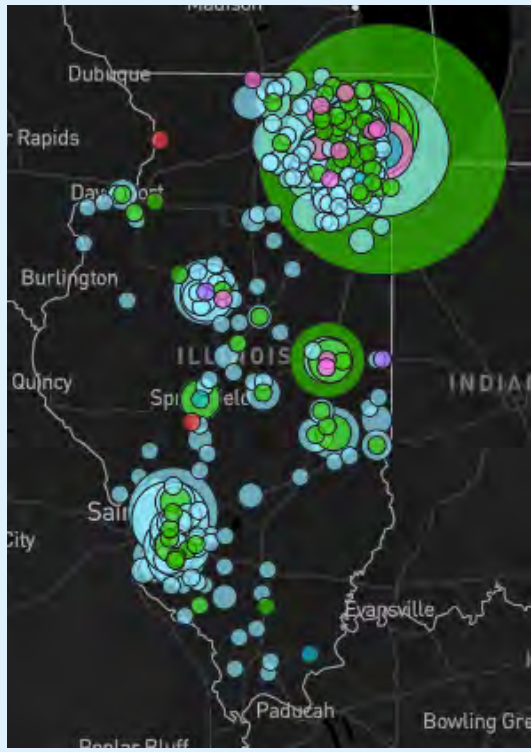

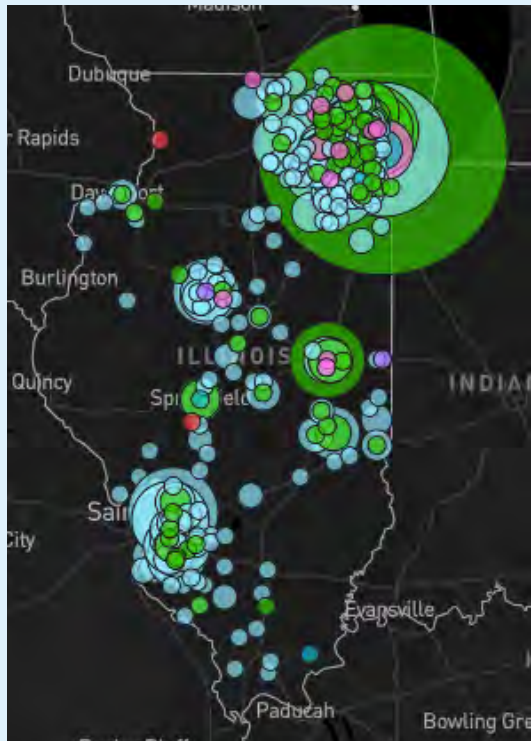

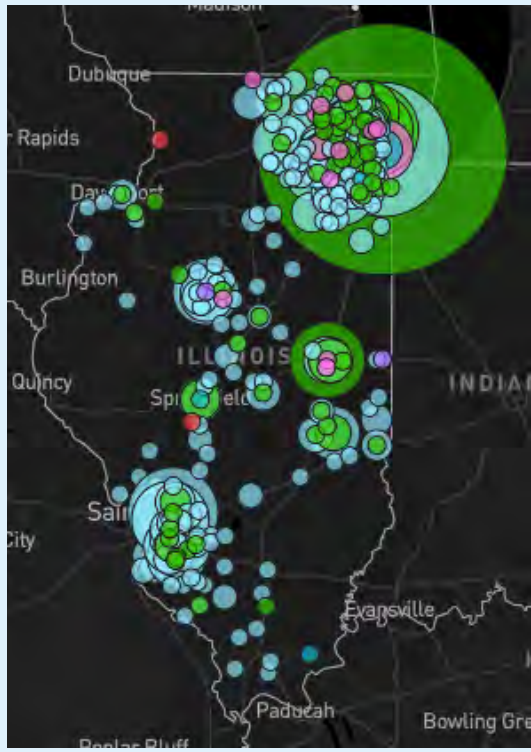

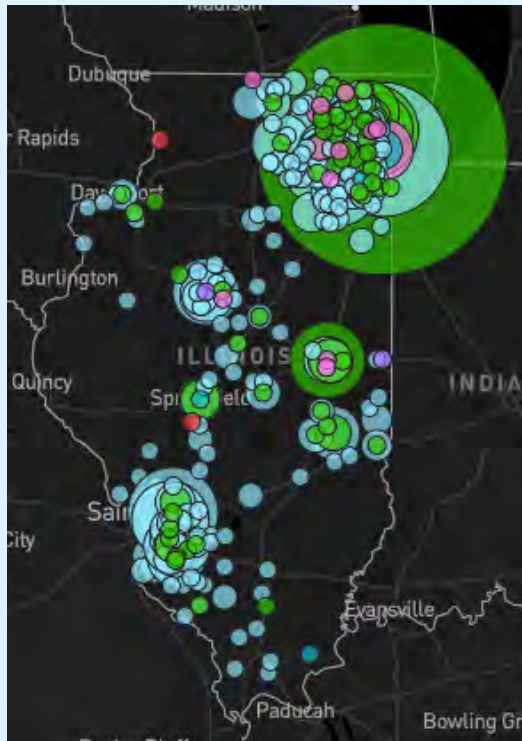

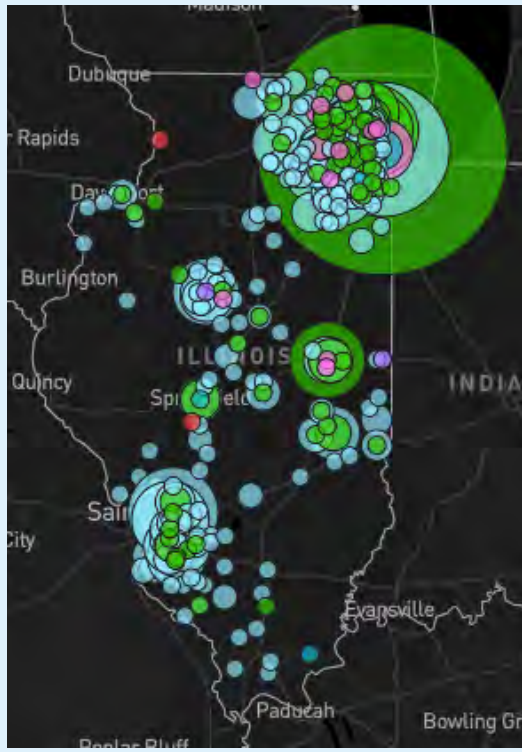
